
AERODROME GROUND **MOVEMENT CHART - ICAO**

WARNING:

- 1. Taxiing of Tu-154, Tu-204, Tu-214, Tu-134, Yak-42, An-12, B727, B737, B757, MD-82, MD-88, A-319, A-320 ACFT along TWY B3, TWY B6 shall be carried out at reduced speed, strictly along the taxi guide line, at idle power.
- 2. Taxiing of II-76, B767, B777, A-300, A-310, A-330 ACFT along TWY B3 and TWY B6 shall be carried out under own engines power on segments from RWY 01/19 to the marking signs of exit from ILS critical area,
- then by towing.

 3. Taxiing of An-124, Il-96, Il-86, Il-76, Il-62, B747, B767, B777, MD-11, A-300, A-310, A-330, A-340 aircraft along TWY B1, B8, M3 (from TWY A2 to TWY A3), M4 shall be carried out at reduced speed, strictly along the taxi guide line, with flight crew's increased caution and during hours of darkness and when visibility is less than 2000m in the day-time:
- taxiing of An-124 aircraft shall be carried out by towing;
 taxiing of Il-96, Il-86, Il-76, Il-62, B747, B767, B777, MD-11, A-300, A-310,
 A-330, A-340 aircraft shall be carried out after the "FOLLOW ME" vehicle.

 4. Taxiing of ACFT with a wingspan of more than 49m along TWY A9, TWY A10,
 TWY C3, TWY C4, TWY M2 (from TWY C3 to TWY A9) is prohibited.
- 5. Taxiing of ACFT with a wingspan of up to 49m along TWY A9, TWY A10, TWY C3, TWY C4, TWY M2 (from TWY C3 to TWY A9) shall be carried out at reduced speed, strictly along the taxi guide line, with the crew's good
- 6. Taxiing of ACFT along TWY A7, TWY A8, TWY A9, TWY A10, TWY C3, TWY C4, TWY C9, TWY M2 (from TWY C3 to TWY A9) during hours of darkness and in daylight hours, when visibility is less than 2000m, shall be carried out after the "FOLLOW ME" vehicle.
- Stand 24 is AVBL for ACFT with a wingspan of not more than 39.8m.
- 8. Stand 23 is AVBL for ACFT with a wingspan of not more than 64.8m.
- 9. Stand 6 is AVBL for ACFT with a wingspan of not more than 41.0m.
